Curtis Fralin, Firestone Norwalk Ventures, LLC ("Applicant"); 11012 Firestone Boulevard (Assessor's Parcel Number 8022-034-014); a request to modify a previously approved master sign program, including three (3) monument signs, within a multi-tenant commercial center currently under construction, known as "Norwalk Auto Plaza".

**Staff Recommendation:** That the Planning Commission adopt Resolution No. 16-32 to approve the modifications to Sign Use Permit No. 284 subject to the conditions of approval contained in Exhibit "A".

**3. NOTICE OF CATEGORICAL EXEMPTION (CLASS 11)  
SIGN USE PERMIT NO. 288**

Wahbah Wahbah (“Applicant”); 12800 Rosecrans Avenue (Assessor’s Parcel Number 8046-005-053); a request to replace an existing freestanding sign with a new pylon sign and reface existing freestanding and canopy signs with new signs as part of a re-branding project for an existing gasoline station to change the brand from Valero to 76.

**Staff Recommendation:** That the Planning Commission adopt Resolution No. 16-33 to approve Sign Use Permit No. 288 subject to the conditions of approval contained in Exhibit “A”.
