The Heritage Group LLC, 12623 Norwalk Boulevard, located to the south of the intersection of Norwalk Boulevard and Imperial Highway (also known as APN 8047-

004-027), a request to: 1) Change the General Plan designation of a portion of the property from Professional Office to Neighborhood Commercial; 2) change the zone designation of a portion of the property from Commercial Office (CO) to Restricted Commercial (C-1); and 3) construct three commercial multi-tenant buildings totaling approximately 11,300 square feet, including a drive-thru cafe.

Staff Recommendation: That the Commission:

- (1) Adopt Resolution No. 15-12 recommending City Council approval of General Plan Amendment No. 173 and adoption of the Negative Declaration;
- (2) Adopt Resolution No. 15-13 recommending City Council approval of Zone Change No. 349;
- (3) Adopt Resolution No. 15-14 to approve Conditional Use Permit No. 969 subject to the Conditions of Approval contained in respective Exhibit "A"; and
- (4) Adopt Resolution No. 15-15 to approve Precise Development Plan No. 1987 subject to the Conditions of Approval contained in respective Exhibit "A".

Planning Commission Action: Tabled applications due to significant changes made to the site plan by the applicant making the applications moot.
