Kenneth D. Arnold for the Gujarati Society ("Applicant"); 12628-12634 Pioneer Boulevard, located approximately 180-feet from the southeast corner of Imperial Highway and Pioneer Boulevard; a request to: 1) construct an addition to expand an existing temple building in two phases; 2) construct a complete remodel of the existing temple building; 3) obtain a variance to allow the proposed addition to

encroach into the required front yard; and 4) change the Zoning Classification of two (2) parcels from Restricted Commercial (C-1) and Parking (P) to General Commercial (C-3).

**Staff Recommendation:** That the Planning Commission:

- (3) Adopt Resolution No. 15-18 to approve Precise Development Plan No. 1865, subject to the Conditions of Approval contained in respective Exhibit "A"; and
- (4) Adopt Resolution No. 15-19 to approve Zone Change No. 344 subject to the Conditions of Approval contained in respective Exhibit "A".
